provide appropriate cancer risk genetic testing. Passing this legislation was first in the country and very forward thinking. Kentucky is going on the offense now against cancer, but particularly early onset cancer. This legislation also strengthened our American Cancer Society Screening Guidelines and made it explicitly clear that Kentucky follows the 45 ACS Screening Guidelines not USPTF starting at 50.

We also worked on legislation to mandate the creating of a colon cancer prevention license plate and tax check off that was unsuccessful. Kentucky Transportation Cabinet is moving to a flat license plate system and we have been able to work with them to get our Colon Cancer License Plate approved administratively.

The Colon Cancer Prevention Project continued to work with the Kentucky Colon Cancer Screening Program to retool the program. We were funded again in the 2018 Legislative Session, but needed to revamp the program and get it restarted. This has taken longer than expected, but program was started and back up and going during 2019. We also continue to work with Kentucky Medicaid to encourage more focus on colon cancer prevention from all of their Medicaid Managed Care Organizations. Medicaid and the State Health Plan continue to be great partners with the Colon Cancer Prevention Project.
